# <u>Director's Recognition for Extraordinary Contributions – Gerry Graziani, Head Caretaker, Eastdale Secondary School</u>

Gerry Graziani has worked with the DSBN for a grand total of 42 years. He started working in the Grounds and Maintenance departments before becoming a caretaker at the former Empire Public School and has worked the last 18 years as Head Caretaker at Eastdale Secondary School.

To the staff and students at Eastdale, he is affectionately known as "Mr. G." He is known for his positive personality and optimistic outlook and really sets the mood and tone of the school. In addition to making it one of the best maintained buildings in the DSBN, he fills the hallways with his singing, cheerful greetings and endearing nicknames. He knows all of the students and interacts with them anywhere and everywhere, whether it be greeting them in the hallways before school starts, popping into a class to check up on someone, or working out side by side with them in the fitness centre after school.

One of the biggest impacts "Mr. G" has made on students' lives is his interaction with the Specialized School to Community (SSTC) students. At lunchtime, he can usually be found sitting with the students in the cafeteria, socializing and talking about their day. He has also been known to join in a SSTC Phys Ed class to play a game of basketball with them. When a student is having a challenging day, they can often be seen around the school, helping "Mr. G." with something, which gives them the time they need to feel better before returning to class. He is that caring adult that many of the students need.

"Mr. G." has earned everyone's respect. Students listen to him and take good care of the building because they don't want to upset him or wipe out the hard work he has done to keep the school clean. When a visitor or someone new comes into Eastdale, "Mr. G." is there to give tours and welcome them and always does so with a smile on his face. For the staff, he makes coming to work every day a lot of fun.

"Mr. G." will be retiring in June. The Eastdale staff and students will miss him singing "Domenic the Donkey" at the holiday assemblies and performing at the talent shows.

# <u>Director's Recognition for Extraordinary Contributions – Lory McMullen and Rudy Klassen, Teachers,</u> ROUTES Program

ROUTES is a program that runs at Crossroads Public School that supports the Low German Mennonite Families in the Niagara Region. Students typically have long gaps of non-attendance for a variety of work and travel related reasons, English language learning needs, and feelings of cultural exclusion within the community. When looking for teachers to work with the school and families on this pilot project, everyone was thrilled that teachers Lory McMullen and Rudy Klassen rose to the challenge.

Lory was a natural fit for the elementary program, coming from a German Mennonite background and having enjoyed several years as an Instructional Coach. She brought the perfect combination of cultural and instructional knowledge, as well as a warm and kind nature.

Lory has worked hard to build independence and interdependence among the students. With children ranging in age from 6 to 13, she knows where each of her students are in their learning, including their strengths, interests and next steps. It is an understatement to say that differentiated instruction is happening in this room.

Lory also engages with the community and has made developing relationships with parents a priority. Within a month of beginning the program, Lory was busy planning a potluck dinner with the students and their families. This evening event was a highlight for all who were able to spend some time around the "dinner table" with these students, their siblings and parents.

But most importantly, Lory builds strong relationships with her students and they sing her praises. One child said, "Mrs. McMullen is always there when I need her. She helps me with my math and she has helped me with my reading. I have worked very hard this year and I read much better now. This is my favourite school year." Another said, "I really like our class because it is quiet and Mrs. McMullen is nice. She is gentle. Whenever there is a problem, Mrs. McMullen helps. We love that she gives us choice in our learning. She makes math fun! I also really liked the evening with our families and great food. We are so happy to have our own space with Mrs. McMullen as our teacher."

Lory's desire and ability to build relationships with the Low German students and their families, combined with her intense work ethic has made the "one room school house" a success.

ROUTES is also a secondary school program, based out of Crossroads Public School with a face-to-face class on Monday nights and online learning opportunities allowing students a way to continue working full-time while earning a high school diploma.

Rudy Klassen has been an amazing asset to this program. His decades of secondary classroom experience and knowledge of the Low German community helped him to instantly connect with this group of learners and support them in achieving success.

The students arrive each Monday night excited to see what Rudy has planned. In their three hours together, he provides unique learning opportunities as well as support and encouragement. Knowing that the students have work commitments during the day, he has made himself available at Crossroads on Monday and Thursday afternoons for students to drop in for homework help. On Friday afternoons, he can be found meeting with students in public libraries that are closer to their homes. He is always available to support the students online as well, having taught them all how to use Google Drive and Docs. The Chromebook computers purchased for the program this year, were the very first computers these students ever used.

Rudy has high expectations and insists that students meet or exceed them while also ensuring their classes have the same rigour as any other secondary program in the DSBN. When asked, he proudly shares how his Low German students tackle critical thinking tasks, and their ability to confidently share ideas and opinions. Rudy's ability to form trusting relationships with these students, and his understanding Low German, have helped the first five students gain their secondary diploma. Now he is supporting another 16 along their journey! With Rudy's help, the 16 students will earn a total of 88 credits this year. Planning, supporting, tracking, assessing all these students and their courses is a complex task that Rudy has refined and mastered.

But most importantly, Rudy has developed relationships with the students that make them want to come to school after a long day at work. One student said, "Mr. Klassen is funny and entertaining. He makes our learning fun. He explains things so that they are easy to understand. He is very encouraging." Another said, "Mr. Klassen understands and helps us. We were raised differently; he understands us and our culture. He respects us."

Rudy's commitment to student success, and his willingness to go above and beyond to support Low German learners, are a key to the program's success.

#### **DSBN Heritage Fair 2019**

On April 26, the Scotiabank Convention Centre was buzzing with sixty junior and intermediate students as they participated in the 16th annual DSBN Heritage Fair. Students had a busy day touring the Niagara Falls History Museum, Drummond Road Cemetery as well as being adjudicated.





#### Silver Birch® & Red Maple™ Student Conference

On April 26 we welcomed 1,418 grade 5 – 8 readers from 69 elementary schools to the Silver Birch® & Red Maple™ Student Conference. Readers participated in two book connected workshops with their peers from across the district and interacted with Canadian Silver Birch® and Red Maple™ nominated authors through a keynote address, small group workshops and book signings. Readers were tasked with a reading target of a minimum of five books to be eligible to participate in the conference which is designed to celebrate their reading accomplishments. Collectively, these readers completed a minimum of 7,090 books which is remarkable!

#### Blue Spruce™ Family Literacy Celebration

On the evening of April 26 we welcomed over 800 young readers with their families to the inaugural Blue Spruce™ Family Literacy Celebration. Families participated in a variety of literacy-based activities, interacted with Blue Spruce authors and were entertained by our very own DSBN Book Worms band during a performance of their original songs which were inspired by some of this year's Blue Spruce™ nominated picture books.

#### **DSBN White Pine™ Student Conference**

The DSBN White Pine™ Student Conference is an annual event where secondary students gather to celebrate literacy and their love of reading. White Pine™ book clubs are based in every school across the DSBN and the books are selected by the Ontario Library Association each year. To really focus on the promotion of reading and its importance, the conference was open to all book clubs in the DSBN.

White Pine™ is a culmination of the reading students have done together all year. Students chose sessions to attend, such as henna design, book folding, yoga, writer's workshops, singing & songwriting, floral design, mosaic creation, cooking, and outdoor survival education, just to name a few. The sessions were all inspired by the books the students have read and the creativity found within. The keynote speaker was selected from the White Pine authors. Tanaz Bhathena, author of A Girl Like That, was the keynote for 2019. This year a Book Swap was included in the event where students could bring books they've loved and swap them for books their peers brought. The students enthusiastically participated and look forward to this positive day each year to foster their love of reading and celebrate the joys of book clubs across the DSBN.





#### **Math Olympics**

On May 1, Greater Fort Erie Secondary School hosted the third annual DSBN Secondary Math Olympics. This event, organized by Laura Tonin, with support from the Curriculum Support Services math team, gathered over 100 students from 14 DSBN secondary schools. The day began with a team challenge in spatial reasoning and then students competed in individual, pair and team events. The team relay was the highlight of the day as teams collaborated to solve problems together. In total, 27 teams competed with Sir Winston Churchill Secondary School's two teams coming in first and second and Westlane Secondary School's Team 1 placing third.

#### **Governor Simcoe SS Robotics**

This year was an incredible year for the Governor Simcoe Secondary School Robotics program, Team 1114 Simbotics. In the VEX Robotics Competition, three of the teams qualified for the Provincial Championship. The team also hosted an event in the fall and the Provincial Championship at Governor Simcoe SS. The FIRST Robotics Competition team went undefeated while winning two district events, going into the Provincial Championship as one of the top teams in Ontario. They ranked first in their division after qualifying, won the division, and proceeded to win the finals, emerging as Provincial Champions.



Going into the World Championships in Detroit, the team was voted the number one robot heading into the event. They competed in an extremely talent-heavy division and still seeded first overall with a record of 9-1. Unfortunately, their incredible season came to a heartbreaking end in the semi-finals of the division in a very close three match series. Governor Simcoe SS has returned to being considered one of the top teams in the World with one of the best robots along with a group of students and mentors who are incredible representatives of their school and the DSBN.

#### **Music Monday**

On May 6, 15 DSBN secondary schools participated in the 12th annual "mass band" version of Music Monday, which was hosted for the public at the Meridian Centre.

Over 400 students and 30 staff came together to work collaboratively to learn, workshop and prepare music new to them in a collaborative manner. It also marked the 1st time that music students played a significant role in planning the workshops and performance alongside their teachers on the planning committee. The genres of music also expanded this year, including jazz, R&B and concert bands, percussion ensemble, a DJ trio, school vocal ensembles and a mass choir that performed this year's Music Monday Anthem, Oscar Peterson's "Hymn to Freedom."

The partnership also included the FirstOntario Performing Arts Centre and Brock's Marilyn I. Walker School for the Fine and Performing Arts who hosted the student musicians for the afternoon workshops, as well as Long & McQuade Musical Instruments for providing equipment and managing the audio set-up and mixing. It is this partnership that allows for the students to showcase their learning journey to their family

and the public, while gaining valuable experience interacting with our partners' professional and industry-standard performance facilities.

The event was documented by two student videographers from Eden High School. Their footage was collected that day and edited in time to be shown at the Meridian Centre before the highlight performance of the mass band.

#### **Mindset Matters Student Leadership Conference**

The Mindset Matters Student Leadership Conference held on May 9 was an opportunity for 16 DSBN schools to showcase the mental health and well-being projects they have been working on this school year. These teams attended three training sessions throughout the year focused on putting research into practice by working to develop school-community-specific social and emotional learning goals. Schools included students on their team, incorporating their input and expertise.

The teams met regularly, with central support from the Mental Health and Well-being team, to develop new innovative practices while at the same time ensuring sustainability. Student voice and leadership were essential in moving the plan into action.

The Mindset Matters Conference provided an opportunity for schools to share their journeys with each other. The gallery walks allowed the participants to visit school booths, ask questions, collect ideas and see how the strategies could work into their own plan. The morning ended with the teams listening to each other, sharing what they learned from other schools, brainstorming and planning for their next steps.

#### **CONNECT Conference**

DSBN recently hosted the CONNECT Conference, Canada's largest independent education technology conference, created by educators and educational leaders and founded by the District School Board of Niagara.

The conference attracted over 2000 participants, plus countless exhibitors and sponsors. There was a great diversity of participants at CONNECT, from students and educators K-12, college and university, chief information officers, IT experts, business managers and innovators in many different business sectors. It was a great success!

#### Diplôme d'études de langues françaises (DELF)

This year, 50 grade 12 students enrolled in core or extended French and challenged the DELF (Diplôme d'études de langues françaises) exam to attempt to earn a certificate indicating attainment of different levels of French proficiency. DELF is based on the CEFR (Common European Framework of Reference) which was used to build Ontario's FSL curriculum. This was the first year DSBN was able to provide an in-Board opportunity for students to challenge the DELF. Last summer, 15 secondary FSL teachers were trained as "correctrices" who would be certified to administer and mark DELF at the DSBN. Through the year, FSL teachers participated in professional development that would help students work towards challenging the DELF. Interested students received a short workshop on DELF to help them decide whether they wish to challenge the exams. The exams for DELF levels A2, B1 and B2 were administered during the week of May 6. It is expected that almost all of the 50 students who participated will be successful at the DELF level they challenged.

#### **DSBN Students Receive Major University Scholarships**

Six DSBN students have been awarded major scholarships from the McCall MacBain Foundation valued at up to \$32,000 over four years to pursue their undergraduate degrees starting this fall. The MacBain Niagara Falls Scholarships were founded by John and Marcy McCall MacBain in 2017.

The recipients are: Larissa Adamo (AN Myer Secondary School), Daniel Krowchuk (Westlane Secondary School), Riley Manels (Stamford Collegiate), Ghazal Razeghi (AN Myer Secondary School), Tori Rigas-DiDomenico (AN Myer Secondary School) and Carter Yacyshyn (AN Myer Secondary School).

MacBain Niagara Falls Scholarship recipients are selected based on the demonstration of strong potential for leadership, positive contributions to their school or broader communities and an overall commitment to excellence. The scholarship supports them over the course of their first undergraduate degree at any Canadian public university. The students participated in extensive interviews which looked beyond academic achievement to examine activities and pursuits in the service of others and across a broad spectrum of leadership roles. Congratulations to all students!

#### **Skills Competition**

On May 7 and 8, staff and students travelled to the Ontario Technological Skills Challenges in Toronto and represented the DSBN with confidence, pride and enthusiasm. All of our students are to be congratulated. To compete at the provincial level is a huge accomplishment and a great learning experience!

The Ontario Association for Mathematics Education (OAME) Award Liisa Suurtamm, DSBN Secondary Math Consultant, was awarded the OAME Award for Leadership in Mathematics Education at the provincial conference in Ottawa earlier this month.

This award recognizes an educator who has demonstrated leadership by contributing in a significant way to the development of mathematics educators and the enhancement of mathematics education in Ontario through innovation and/or research related activities. In Liisa's role she is responsible for supporting the professional learning for DSBN secondary math teachers which includes setting the direction and focus for the math learning on the Board wide PD Day, facilitating learning teams at board and school level, planning and facilitating bi-monthly Program Leaders meetings. She also provides weekly support in DSBN focus schools providing one-on-one support in classrooms.



Liisa always grounds the work she does in research. Over the past few years, Liisa has facilitated learning around: From Patterns to Algebra, The Five Practices, Spiralling, Teaching Through Problem Solving and Creating Thinking Classrooms. Also, Liisa has led book studies around The Five Practices, Principles to Action, Make it Stick and Mathematical Mindsets. Through her work with the DSBN math program leaders, Liisa promotes their leadership by empowering them to make decisions regarding their own math teams, having them regularly look at their role, and introducing them to new ideas and current research.

This award is in recognition of Mike's outstanding commitment to Technological Education; his students and colleagues through the delivery of creative and engaging programs, active involvement and leadership roles, professional development and life-long learning.

Along with this recognition, Mike will receive a bursary of \$500 to be used for the postsecondary education/career of a student selected by Mike.

#### **Landscape of Nations**

Six Nations of the Grand River — The Woodland Cultural Centre is pleased to announce the launch of phase two of the Landscape of Nations 360° Indigenous Education Initiative and DSBN is the lead education partner in the initiative with The Woodland Cultural Centre. Following the successful implementation of phase one, that organized a roundtable of academic scholars, master teachers, and Indigenous culture and language specialists to research, produce, and publish the Framework For Essential Understandings About Indigenous Peoples of the Niagara Region, phase two will focus on the development of a professional

teacher training program designed to increase competence and confidence among educators responsible for teaching Indigenous subject matter which begins with some DSBN teachers in June.

The Landscape of Nations 360° Indigenous Education Initiative is part of the ongoing work being done to convey and enhance the meaning and messages of the Landscape of Nations Commemorative Memorial that was dedicated on October 2, 2016 in Queenston Heights Park, and through other important Indigenous historic sites and installations within the region.

Until recently the inclusion of Indigenous history — and Indigenous content integrated within other disciplines — was virtually absent from school texts and tutorials. And when some level of information was present it often lacked the full 360° perspectives that fostered critical thinking skills that are vital to arriving at a balanced and accurate assessment of events and outcomes. There was little evidence in classroom materials of important historical and contemporary events involving Indigenous peoples, their knowledge and perspective, and little or no integration of those events into the larger narratives of Canadian history.

Landscape of Nations 360° intends to help shift that paradigm.

The District School Board of Niagara is proud to partner with the Landscape of Nations 360° in this project to support both teacher and student learning in this critical area.

#### **Exciting Updates from Pine Grove Public School**



It's been an exciting couple of weeks at Pine Grove Public School. A group of students on the Technovation Team were selected to be part of a live broadcast called "We Day Connect." This was an online televised event that featured five different schools globally doing some incredible work on service-learning campaigns, hosted by Spencer West a world-renowned speaker and athlete most popular for being the first amputee to ever reach the peak of Mount Kilimanjaro. The theme of the grade seven students' app, "Imagine That," involves bringing awareness and education to inclusive language surrounding those with a disability. At the end of the segment Pine Grove Public School was surprised with a \$1,000 grant to use towards inclusive technology as well as a Microsoft Surface Pro.

Also, the staff of Pine Grove Public School has been selected by EQAO for the 2018 Dr. Bette M. Stephenson Recognition of Achievement award. Each year, EQAO celebrates schools that supported students' passion, which led to academic success in math. Pine Grove Public School was selected based on their demonstrated improvement in EQAO results over the last three years by fostering strong attitudes toward math. #### **MINUTES OF MEETING**

#### Approval of the Agenda

Westlane motioned the agenda be approved. Governor Simcoe seconded the motion. Motion carried.

#### **Report from Student Trustees**

Amal introduced incoming Student Trustee Karina Tavernese. Karina looks forward to working with the Senators during her two-year term.

#### Mindset Matters Conference

Keylee briefed the Senators about recent DSBN events. She introduced Mental Health Lead Isaac Virag to the Senators. He updated the Senators on the Mindset Matters Conference, noting its tie-in with Mental Health Week. Of note was the participation of eight DSBN focus schools promoting mental health and wellbeing. Amal thanked Mr. Virag and his team for supporting this event.

#### 2021 Mascot Challenge

Senators can connect with the Student Trustees if they are interested in promoting the 2021 Mascot Challenge event in their schools.

#### **Dress Code Guidelines**

Superintendent Smith clarified the language around the dress code update presented at the April Student Trustee Senate meeting. She wanted to make clear that this was a guideline and not a policy. Senators' feedback was shared with Superintendent Pisek who chairs the Committee that oversees the DSBN Code of Conduct.

#### **OSTA AECO**

An eLearning survey has been launched to gather information from students across the province who have taken eLearning courses.

#### **Report from Trustees**

Trustee Schaubel reported that DSBN school enrollment has increased and acknowledged stresses in the system regarding staffing. He thanked the students for their involvement in Student Trustee Senate and requested that they encourage candidates from their schools to continue their work.

#### **Around the Table:**

The following schools briefly summarized the results from school-based Student Voice Forum:

AN Myer – students already have a sense of belonging; extra-curricular clubs are perceived as unwelcoming; students want more information on life skills; they want more teacher feedback; access to group tutor sessions; better communication between teachers when assigning homework to prevent overwhelming students.

Beamsville – request for mental health supports and homework help; students enjoy having eLearning as an option but do not want it made mandatory; more support needed for bullying and mental health concerns; more information on post-secondary life skills and career planning.

DSBN Academy – access to mental well-being support; financial literacy and money management.

EL Crossley – students want ELC to be an MSIP school; help with eLearning courses – students want teachers trained in certain courses to be there to provide support; awareness and access to mental health resources; skills courses for post-secondary life.

Eastdale – students want to feel welcome at school by peers and teachers; students want financial literacy, more well-being supports; tutoring and one on one help; variety in teaching methods.

Eden – teachers could be more welcoming and approachable; more support in life skills and managing work-life balance.

Governor Simcoe – better communication between staff and students; approachable and caring teachers; better advertising for resources available at school; financial literacy and university preparation through workshops; more university style classes and less "babying" of students.

Greater Fort Erie – stronger communication of expectations from teachers; ways to strengthen school community through clubs and school merchandise; interest in MSIP; earlier and frequent Guidance meetings; better preparation for post-secondary life through support groups to help transitions.

Grimsby – 86% of students surveyed feel a sense of belonging; the school needs more groups and clubs that reach to all ages, interests; students want more approachable teachers; more variety in teaching methods.

Laura Secord – want more availability and diversity of resources in school; MSIP classes should offer more choice; students feel connected by the lack of grade separation, enjoy having friends in other grades; more preparation for post-secondary life.

Port Colborne – students want to be treated like university students in terms of atmosphere and deadlines; students feel there is a lack of communication between students, staff and administration; open door policy would help address this.

Saint Catharines Collegiate - students want a specific day to hold workshops; access to resources like social worker, nurse, principal and vice-principal; school coding class wants to create an app to link services to a virtual billboard.

Sir Winston Churchill –students not aware of supports that they can access; they struggle to schedule extracurriculars; want their opinions to be heard in clubs; find keeping up in classes difficult without eLearning; breakfast club needs better support as students feel unacknowledged.

Stamford – no SVF held but a survey was sent out via the school Mental Health Committee to gauge well-being; main focus on teacher relationships and mental health resources.

Welland Centennial – kind and supporting teachers to promote a sense of belonging; being greeted; interest in being an MSIP school; students fear that they aren't good enough to try out for teams, and homework load does not allow it; students want more financial literacy; more help from Guidance to help with course choices to support career planning.

Westlane – inclusiveness through class discussion and more decisions on due dates; more support on courses not math-based i.e. science, essay help, history; teacher connections make for more student involvement in education. Mutual respect yields better results.

Amal asked Senators to share ideas on how to engage students with mental health supports. Suggestions included advertising to promote awareness such as hanging posters on the washroom stall door and assemblies featuring the Mental Health Team. All schools should have a Mental Health Committee. There is interest in scheduling appointments with the social worker and school nurse online to ensure accessibility and confidentiality.

#### POLICY J-01: TRANSPORTATION ELIGIBILITY AND SERVICE

Superintendent of Business Services Stacy Veld introduced Superintendent of Education Michael St. John and Executive Director of Niagara Student Transportation Services, Lori Powell to present Policy J-01: Transportation Eligibility and Service.

Superintendent St. John stated that transportation continues to be harmonized with our coterminous Board. He shared that feedback received through the vetting process was taken into consideration and the suggested revisions reflect updated terminology and clarity. Executive Director Powell reiterated that in situations where a student does not qualify for transportation under the Board's eligibility criteria, it is the parent/guardians' responsibility to ensure that their child gets to and from school safely.

#### 2018-19 INTERIM FINANCIAL REPORT

Superintendent Veld presented the second 2018-19 Interim Financial Report which provides a comparison of year-to-date actual revenue and expenditures to the prior year, explains key variances from budget, and forms a conclusion as to the projected surplus for the year. The report did not reflect many changes from what was presented to Trustees in January 2019 as the enrolment projection is the same, therefore, the Grants for Student Needs are also in line with the January reporting. The second Interim Financial Report has resulted in a projected general operating deficit of \$1.46M for the 2018-19 fiscal year. In the original budget, it was projected to use \$3.79M of the general operating reserves to balance our budget. Based on our preliminary data, we will have an in-year surplus of over \$2.3M. This significant surplus is primarily due to the increase in enrolment and the resulting increase to Grants for Student Needs. This preliminary projection is based on actual spending to February 28, 2019 and includes the projected expenditure relating to the SHSM technology infusion that Trustees approved in January. Updated results of the 2018-19 fiscal year will be provided at the June 2019 Finance Committee meeting in our third interim report.

Superintendent Veld introduced Controller of Finance, Nicky Westlake to outline some of the specific changes in revenue and expenditures.

Director of Education Warren Hoshizaki shared that a report will be presented at the next Finance Committee meeting outlining an initiative to create a base amount of technology provided to all schools throughout the system.

#### **MULTI-YEAR CAPITAL PLAN**

Superintendent Veld presented the Multi-Year Capital Plan which is prepared by staff each year to address various capital needs within the DSBN related to school renewal (including program needs), accessibility improvements, major capital construction and administrative capital projects. The Board of Trustees receive this five-year plan and are asked to approve the projects set out for the subsequent school year.

The Plan is developed through identified needs and prioritized from previous school condition surveys, facility renewal requests from schools, instructional space requirements, education program needs and accessibility improvement requirements that we are mandated to achieve. All proposed projects have been reviewed in detail by Senior Administration and reflect program needs and priorities of the system.

The capital plan identifies just over \$29M in funding and expenditures for the 2019-20 year and includes summaries of revenue and expenditures, including details identifying the types of construction projects forthcoming. The Province recently announced that funding will continue to be received for school condition improvements in addition to our annual GSN allocation of school renewal for 2019-20.

During the 2018-19 year, we were advised that the Province was eliminating the Greenhouse Gas Reduction Fund and the Community Hub Capital funding, however, DSBN was able to receive the full allocation of these funds in the current year as we had already planned and started these projects. We plan to spend over \$14M dollars in capital priority funding and \$1.4M in proceeds of disposition. In addition to these projects, the DSBN has prepared a plan for school renewal that continues to include accessibility needs, science lab upgrades and the start of a 5-year program for asphalt repairs to parking lots and tarmacs totalling over \$3.5M.

Superintendent Veld introduced Manager of Projects and Maintenance, Bob Dunn to highlight some of the capital work planned for 2019-20 including an update on our Board's accessibility initiatives. Bob shared that overall, 87% of our buildings are 91%-100% accessible, an increase of 3% since the last report. 32% of our inventory is 100% accessible. Provincial guidelines indicate all schools be accessible by 2025.

Bob identified there are over 100 various detailed school renewal and school condition projects for 2019-20. DSBN was noted by the Audit Committee as the leading Board in Ontario for keeping a building preventative maintenance renewal model with a planned approach to repairs.

#### 2019-20 PRELIMINARY REVENUE BUDGET

Superintendent Veld presented the 2019-20 preliminary revenue budget report to the Committee which included day school enrolment projections, a summary of grants for student needs, a total revenue summary and a schedule of accumulated surplus funds. The expenditure budget including potential increases and decreases will be presented for Trustees' consideration at the June 19<sup>th</sup> Finance Committee meeting.

Trustees were reminded that the Board's projections of student enrolment have the largest impact on the revenue received from the Province. The projected 2019-20 average daily enrolment or ADE is an overall increase of 188 or 0.05% from the 2018-19 actual enrolment, representing an increase in the elementary panel of 238 and a decrease of 50 in the secondary panel.

Included in the report are identified changes in the grant revenues announced as part of the budget released by the Province. Some are a continuation of the commitments made in provincial bargaining and others are the continuation of prior year initiatives such as the Special Education additional funding, mental health workers, NTIP funding and increases to support operational cost increases in transportation and utilities. Included in the preliminary revenue summary, is the use of \$1,850,000 of general operating accumulated surplus as per the May 2017 Board motion.

The DSBN has committed to no layoffs of staff as a result of the Provincial reductions to Education Funding. This however does not mean that there are not concerns with the secondary class size changes. Director Hoshizaki shared that some central staff positions may be placed back in classrooms as necessary.

Superintendent Veld invited Nicky Westlake to further discuss the Preliminary Grant Revenue Budget. Nicky reiterated that the Pupil Foundation Grant is the Board's major source of revenue from the Province. Comparing to the prior year, the DSBN is experiencing a decrease in this grant of \$8.5M. This is the net effect of an increase in funding due to enrolment and the reduction of funding based on the increased class size changes.

Nicky shared as announced by the Ministry, they are providing Attrition Protection Allocation for up to four years to protect staff impacted by the change to class sizes, allowing school boards to phase in the proposed class sizes. This funding is provided through the Cost Adjustment and Qualification Grant. Overall this attrition factor has mitigated the funding loss in the Pupil Foundation Grant with the only reduction being offset by the reduction in expenditures for retired secondary teachers.

The other significant decrease in funding is the Learning Opportunities funding of \$4.2M as a result of the loss of the Local Priorities Fund.

# CODE OF CONDUCT INVESTIGATION (COCI) COMMITTEE FINDINGS OF FACT RE: FORMAL INVESTIGATION

# <u>Summary of Allegation (based on the Reporting Trustee's Written Complaint and Oral Interview)</u>

- St. Catharines Standard published an article titled "DSBN trustee wants performance review of education director" on January 25, 2019, which quoted Trustee Baggott who was identified with her quotes as "a representative for St. Catharines and Niagara-onthe-Lake"
- The allegation of the Reporting Trustee includes that Trustee Baggott spoke as a DSBN representative without the authority of the Board and that she was speaking about sensitive matters about personnel
- As a result of the article, the Reporting Trustee was asked by constituents if the DSBN was getting a new Director of Education

#### **Process & Timeline:**

- Date of Alleged Breach: January 25, 2019
- Date COCI Committee Advised of the Alleged Breach: February 20, 2019
- Allegation that the following sections of the Board's Code of Conduct were breached:
  - Section 5
    - "Trustees of the Board shall discharge their duties loyally, faithfully, impartially and in a manner that will inspire public confidence in the abilities and integrity of the Board."
  - o Section 28
    - "The Chair of the Board is the spokesperson to the public on behalf of the Board, unless otherwise determined by the Board. No other Trustee shall speak on behalf of the Board unless expressly authorized by the Chair of the Board or Board to do so. When individual Trustees express their opinions in public, they must make it clear that they are not speaking on behalf of the Board."
- Reporting Trustee was interviewed on: February 20, 2019
- Witnesses of the Reporting Trustee were interviewed on: N/A
- Written Complaint was given to the Trustee who is subject of the Complaint on:
   February 27, 2019
- Trustee who is subject of the Complaint was interviewed on: oral interview declined (when offered the opportunity for an oral interview in addition to written response received)
- Trustee who is subject of the Complaint provided a written statement/response on: March 7, 2019
- Witnesses of the Trustee who is subject of the Complaint were interviewed on: The
  Trustee who is subject of the complaint offered "as witnesses to this
  documentation" (being her written response), the names and Facebook links for
  reference to their public comments. The COCI Committee reviewed the Facebook
  pages suggested, which also contained the comments from the other 3 witnesses
  referenced in the written response

#### **Findings of Fact:**

- Trustee Baggott raises allegations about Trustee Fast's prior communication with the media in 2013, 2014 and 2015
- The COCI Committee finds that the Committee has no jurisdiction to review events that occurred prior to the implementation of the Board's Code of Conduct in September 2018

The Code of Conduct Investigation Committee finds the following facts:

- In the article, Trustee Baggott was identified as "a representative for St. Catharines and Niagara-on-the-Lake"
- In her written response, Trustee Baggott did not refute that the comments in the article in the St. Catharines Standard were made by her or that they contained any inaccuracies
- In her written response, Trustee Baggott did not provide evidence that she requested a retraction of the comments attributed to her in the article in the St. Catharine Standard
- In her written response, Trustee Baggott did not provide evidence that she had the authority of the Board to speak on behalf of the Board
- In his oral interview, Trustee Fast confirmed that people in his area read the article and approached him and stated "I see you are getting a new Director", which caused him concern, coupled with his belief that her comments made the Board look unprofessional
- Trustee Baggott confirmed in her written statement that based on the comments on the Standard's Facebook page, the article increased confidence in the Board
- However, the COCI Committee finds that the comments included on the Standard's Facebook page while supportive of Trustee Baggott's action to suggest a policy were negative about the DSBN with pointed negative references about the DSBN's current Director

# Report to Board DSBN Strategic Plan Process 2020-2025 May 28, 2019

#### **Background:**

The District School Board of Niagara's Strategic Plan was developed to provide direction, focus and guide the work of schools in order to enhance student learning.

The Strategic Plan defines DSBN's:

- Mission: "the DSBN is Committed to Student Success by Working Together to Inspire, Empower, and Support all Learners to Achieve their Full Potential"
- Vision: "Achieving Success Together"
- Core Values: "Respect, Relationships and Responsibility"
- Strategic Priorities: "Student Growth, Staff Growth and System Growth"

The Strategic Plan was developed in 2005-2006 with the input of all stakeholder groups within the DSBN including parents, trustees, school administrators, administrative staff, unions, federations and superintendents. This working committee met for several full days, which meetings were led by an outside facilitator. Commitment to student success was the focus of the Strategic Plan. Three major areas of emphasis were identified as: student growth, staff growth and system growth.

A one day *Reflection, Review and Renewal* session of the Strategic Plan took place in March 2008 and participants were asked to provide feedback on the initial plan established in 2005-2006.

In 2009-2010, the Strategic Plan was reviewed in order to set direction for the following five years. Participants from DSBN stakeholder groups were given the opportunity to celebrate successes, express opinions, and provide feedback and input. Once the review was complete, the Plan was modified slightly to include updated information.

In 2015-2016, the Strategic Plan was reviewed once again in an effort to continue to ensure all voices were heard including students, parents, community members, Indigenous, trustees, school administrators, administrative staff, teachers, school council members, unions, federations and the senior team. These DSBN stakeholder groups provided input into their thoughts and ideas on what the DSBN's priorities should be and how to continue to best move the system forward in a positive way. The meetings were led by an outside facilitator, followed by an electronic consultation process.

Now, five years later and with a strong foundation to build upon, it is time to revisit the DSBN Strategic Plan to set direction for the next five years. The first step in the process is to engage an individual to facilitate planning sessions as well as a company to obtain feedback electronically from DSBN stakeholder groups and the broader community.

#### **Estimated Cost:**

The estimated cost to review the DSBN Strategic Plan is \$40,000.

#### **Timelines:**

- Revisiting of the DSBN Strategic Plan to begin September 2019
- The Board of Trustees to approve the DSBN Strategic Plan 2020-2025 in March/April 2020
- DSBN Strategic Plan 2020-2025 to be implemented September 2020

#### **Recommendation:**

"That the Board appoint up to five trustees (one as Chair of the committee) to be members of the Ad Hoc DSBN Strategic Plan 2020-2025 Advisory Committee."
