### **BACKGROUND:**

On Thursday, November 16, 2017 the Educational Research Committee met to review one newly proposed research project.

### PROPOSAL #1 Summary

- a) Title of Research: The Development of Young Children's Spatial Reasoning and its Role in Mathematics Learning (also known as Math for Young Children Principal Investigator(s): Dr. Cathy Bruce, Professor, Dean of Education, Trent University
- b) Objectives/Rationale/Purpose: Mathematics is a crucial area of learning for young children and is shown to be a predictor of later success in mathematics and beyond (Duncan et al., 2007; Jordan & Levine, 2009; Watts, Duncan, Siegler & Davis-Kean, 2014). Spatial reasoning is a predictor of mathematics achievement (Mix & Cheng, 2013) and is relied upon across the mathematics curriculum (National Research Council, 2009), yet very little is known about how to explicitly support children's spatial reasoning. Our research in this area has been ongoing in the province of Ontario since 2011.
- c) Number of Schools: 3-5
- d) Age of Student Participants: JK-1
- e) To Commence/Conclude: December 7, 2017-April 30, 2018
- f) Time Requirements: task-based interviews with students (5-10 per class) conducted by teachers on the inquiry team, interview and survey with teachers in final session, designed as a component to a professional learning cycle of inquiry in which the teachers have already planned to engage over the course of 5 release days (one per month from December to April).

We, the Educational Research Committee, recommend this research be APPROVED.

### **Background:**

The Education Act, Regulation 304 — School Year Calendar, Professional Activity Days, sets the requirements for the preparation and submission of school year calendars to the Ministry of Education for approval.

The 2018-2019 calendar provides for 194 possible school days between September 1, 2018 and June 30, 2019. The school year shall include a minimum of 194 school days of which three days shall be designated as professional activity days. In addition, up to four days may be designated by the board as professional activity days. The remaining school days shall be instructional days. The board may designate up to ten instructional days as examination days.

# SECONDARY SCHOOL PROGRAM REVIEW FOR THE CURRENT SCHOOL YEAR 2017-18 Program and Planning Committee February 6, 2018

### **Introduction and Background**

In accordance with Administrative Procedure 4-3, in the fall of 2017, school data has been gathered by the Superintendents of Area 7 Schools for the District School Board of Niagara working in association with the Student Achievement Leader (9-12). The following summary has been developed, based on this data, to indicate Board-wide trends in the secondary school course offerings for the 2017-18 school year.

### Adherence to the Guaranteed Minimum Offerings at School, Program Area and System Levels

For the current school year, all five program areas were 100% successful in meeting the minimum requirements for their program area. 16 out of 17 Secondary schools have demonstrated 100% adherence to the guaranteed minimum course offerings.

### **Breadth of Program in DSBN Secondary Schools**

- There is a net decrease of 38 courses across all 17 secondary schools.
- Open level courses and courses with University, University/College and Academic destinations have the largest overall net decrease in courses running.
- Arts and Canada and World Studies have the greatest decrease (-10 and -11 respectively.)
   English has the greatest increase (+3)

### School Administrator's View of School Program Needs and Concerns

The review process provides an opportunity for Principals to express their needs and concerns relative to program and staffing for their individual schools. The most common comments submitted by principals include:

- concerns at smaller schools with Specialized School To Work (SSTW) programming being able to provide enough university and university/college courses for senior students.
- a continued increase in the number of combined classes due to enrolment changes.
- the increased number of teachers shared between schools is creating scheduling difficulties.

### **Summary**

The 2017-18 courses offered in the secondary schools of the District School Board of Niagara continue to provide a wide range of offerings for students participating in all destination areas. The course offerings and variety of courses are stable.

### Introduction

In accordance with Administrative Procedure 4-3, in the fall of 2017 school data was gathered by the Superintendents of Area 7 Schools for the District School Board of Niagara, working in association with the Student Achievement Leader (9-12). Based on this data, the following summary was developed to indicate Board-wide trends in the secondary school course offerings for the 2018-19 school year.

This Program Review attempts to provide a forecast of the overall program available to students for the next school year across the Board's secondary schools.

### **Detailed Summary of Review**

In the fall of every year, our secondary schools make decisions regarding which courses need to be added to / deleted from option sheets for the following school year. Principals are guided by the Board's *Minimum Course Offerings at School, Program Area and System Levels,* changes to Ministry of Education curricula, as well as by the needs of the students in each school.

### Key findings:

- majority of the increases and decreases are a direct result of new curriculum offerings.
- net course offerings will increase minimally for the 2017-2018 school year by a total of 23 courses across the 17 secondary schools.

### **Identified Program Developments and Problematic Areas**

The following were the most commonly cited comments by principals as they look at the year ahead:

- enrolment at some Specialized School to Work (SSTW) sites poses a programming problem in maintaining programs in some subject areas and for students pursuing certain destinations.
- the number of combined/split classes pose challenges.

### **Adherence to the DSBN Guaranteed Minimum Offerings**

Based on the data submitted under this Review, there is no reason to doubt that the secondary schools and program areas of DSBN will continue to demonstrate strong adherence to the Board's Policy on Guaranteed Minimum Offerings in the 2018-2019 school year. As a result, students of all destinations will have an appropriate range of course offerings to meet their needs as set out in this Policy.

### **Summary**

The proposed 2018-19 course offerings in the secondary schools of the District School Board of Niagara continue to provide a broad range of course offerings for students of all destinations. There has been some increase in the number of proposed courses in a majority of subject areas, in the number of proposed courses for each destination and in the number of proposed courses for each of the Intermediate and Senior Divisions. Schools are to be commended for their efforts in maintaining their breadth of program offerings.
