#### REGIONAL INTERNAL AUDIT TEAM UPDATE

Regional Internal Audit Team Manager Jenny Baker reported on the RIAT's work undertaken since September 11, 2017.

#### Planned Audits:

Repairs and Maintenance: Staff meetings have taken place. The key Facility Services staff contacts

are Robert Dunn, Bert Poort, Brian Corish and Elaine Vandenberg. The Terms of Reference for this audit were provided to the Committee. Estimated completion date is April 30, 2018. RIAT member John Forte is

executing the audit with Jenny Baker overseeing the project.

## Completed Audits Follow-Up

Technology Security & Network Penetration Testing:

The DSBN IT department staff, in response to recommendations of the Technology Security & Network Penetration Testing audit, have devised detailed action plans and are providing feedback to Jenny Baker on tests done that can confirm what actions have taken place. Jenny noted that this is a complex area and determining how to report back for follow-up purposes was an integral component. A report will be ready in the new year. She was impressed on the progress made by the DSBN ITS department with over 80% of the action plans already addressed.

## Other:

An SBO (Superintendents of Business)-Regional Internal Audit Steering Committee meeting was held on October 27th. Stacy Veld represents the DSBN on this committee, along with the other nine senior business officials which make up the West of Central Region for internal audit purposes. Jenny Baker explained that this group meets twice a year with the mandate to assist in the coordination and implementation of the internal audit initiative in the Region and to facilitate discussions and action, where required. At the October meeting, discussion took place on all of the audits, i.e. common risks, successes, putting strong practices together.

#### ANNUAL REPORT TO THE MINISTRY OF EDUCATION

Ontario Regulation 361/10 requires the Audit Committee to provide an annual report to the Ministry of Education confirming the internal audits performed during each fiscal year.

Superintendent Stacy Veld reviewed the report which notes that the BAS 2000 Data Analytic Review and IT Backup, Disaster & Recovery audits were completed in the year ended August 31, 2017. In addition, the School Generated Funds audit follow-up review was completed and the Information Technology – Network Security & Penetration Testing audit was completed with presentation to the Audit Committee in September, 2017. The report also confirms, for the Ministry's information, that no enrolment audits are scheduled.

Superintendent Veld commented that great work was done by the Regional Internal Audit Team, especially in light of their staffing shortfall this past year.

### REGIONAL INTERNAL AUDIT FUNCTION MANDATE

Superintendent Veld explained that the Audit Committee adopted the revised Regional Internal Audit Function Mandate in November 2016, per the Ministry of Education's request. The Mandate formally defines the purpose, authority and responsibility of the regional internal audit function. The Ministry also requests that the Mandate be presented to the audit committee annually and re-signed whenever there is a change in the position of chair or its membership so that all parties are aware of and approve the mandate. With the addition of Yusuf Essop to the Committee, the Mandate was provided to the Committee for their review and will be signed by the appropriate signatories.
