#### 4. TRUSTEE COMMUNICATIONS AND SCHOOL LIAISON

- a) Trustee Campbell and Chair Barnett spoke to Education Foundation of Niagara initiatives, including Porta Backyarda Ultimate Staycation which gives participants the chance to win one of two luxury sheds. Tickets can be purchased online at efiniagara.dsbn.org.
- b) Trustee Beamer shared a letter from a parent who voiced concerns about students in primary grades not wearing masks. Director Hoshizaki explained that DSBN follows the direction of Public Health on these matters, but he will raise this concern again during their weekly meeting.
- c) Vice Chair Bradnam reported that the Eden Spiritual Life Virtual Banquet raised over \$40,000. Over 400 meals were prepared and picked up in the drive thru and the night also included a silent auction.
- d) In response to a request by a trustee, Director Hoshizaki explained that DSBN Cares is a fund that DSBN staff and trustees are contributing to in order to support DSBN families. From March 2020 to June 2020 over \$100,000 was raised. Donations are currently being accepted for families in need during this holiday season.
- e) Chair Barnett thanked *Riders Protecting Children* who recently fundraised to provide winter boots to children at risk at 5 different schools.

## 5. Ontario Public School Boards' Association (OPSBA) Report

Trustee Baggott reported that she submitted the feedback that trustees provided during the November 2020 Board meeting regarding the Ministry of Education's move to expand the mandate for TVO related to on-line learning.

Trustee Baggott added that she summarized the content of the discussion and added commentary about the success of DSBN's own courses.

Trustee Baggott noted that DSBN's feedback is similar to that of boards across the province who would like to keep leveraging the expertise that has been developed.
