Trustee Campbell reported that at the February SAL Committee meeting, five (5) applications for SAL were presented and reviewed by the Committee. All five (5) cases were approved for SAL. The Committee reviewed fifteen active cases. Of the fifteen (15) cases, ten (10) are active and compliant with the SAL plans. Five (5) cases have been discontinued. Of those five (5), there are three (3) students returning to full-time learning, one (1) case discontinued for non-compliance and one (1) student has left the school district.

## 5. Report of the Special Education Advisory Committee

Trustee Mitchell provided an update from the February 10 Special Education Advisory Committee where new SEAC member Gabriela Ortega, of Inclusion Action Ontario, was welcomed and guest presenter Dorothy Harvey, the Director of Clinical Services at the Niagara Children's Centre (NCC), provided an overview of the organization's role and responsibilities as a Children's treatment rehabilitation centre. Also presented was an update on permanent contract Educational Assistant positions. Information was shared on Policy and Program Memorandum 81 (PPM 81), Provision of Health Support Services in School Settings. School boards have been given the opportunity to provide feedback on the draft PPM 81 and SEAC will be informed throughout the process. In addition, responses to questions submitted by a SEAC member were presented that included outlining the approval of software and apps in a school setting, the grade 8-9 transition process and secondary programming for students with intellectual disabilities, and the use of assessment tools in special education classes were outlined.

## 6. Report of the Student Trustee Senate

Student Trustee Patel provided an update on the February 15 Student Trustee Senate Meeting, where the senate was introduced to the upcoming Student Trustee elections in April. During subcommittees students discussed the transition to second semester and concluded the meeting with a roundtable discussion. The consensus was that the transition has been smooth, with many students appreciating the normalcy and rhythm of regular class schedules and in-person learning. Student Trustee Steinbach-Parker provided an update on the February 18-19 OSTA-AECO's annual Board Council Conference. DSBN Student Trustees met with student trustees from across the province to discuss current issues in the education system. There were information sessions given by keynote speakers, such as Minister of Education, Stephen Lecce.

## K. QUESTIONS ASKED OF AND BY BOARD MEMBERS

In response to a question, Director Hoshizaki noted that, beginning today, DSBN discontinued providing cohort contact information to Niagara Region Public Health for COVID-19 positive cases and cohort dismissals. The four School Boards in Niagara will continue to follow Ontario Ministry of Education and Ministry of Health provincial direction and report absenteeism rates of 30% or higher due to illness in schools.
