WELCOME AND INTRODUCTIONS

Chair Cheryl Keddy Scott called the meeting of the Policy Committee to order at 5:12 p.m.

APPROVAL OF AGENDA

NEW BUSINESS

POLICY A-01: STUDENT TRUSTEES ON BOARDS

Superintendent of Education Paula MacKinnon stated that the policy was reviewed last year. At that time little feedback was received and some minor changes were made. Student Trustee Samir Alazzam proposed that the policy be changed from a one year term to a two year term for a Student Trustee position. Superintendent Paula MacKinnon stated that the current policy allows students to run for a second one year term, provided they are re-elected by the Student Trustee Senate.

Superintendent Paula MacKinnon presented the following concerns with the two year term proposal:

- Fewer students would experience this leadership opportunity
- Students would have to come forward for election in their grade 10 year and may not have had the opportunity to be a member of the Student Trustee Senate prior to running for election

• A two year term is a large time commitment for secondary students to take on for grade 11 and 12; students would need to know in their grade 10 year that they can make that commitment. This may also limit the number of candidates that come forward

Student Trustee Samir Alazaam presented the following benefits with the two year term proposal:

- Opportunity for larger initiatives, one year may not be enough time for completing a project
- More opportunity for students to hold a position at a provincial level with the provincial student trustee organization
- Staggered terms allow for mentorship opportunities as the new student trustee works with a returning student trustee

Following discussion, the Trustees agreed to a one year pilot project whereby Policy A-01 would be amended to allow staggered two year terms for student trustees. At the upcoming election in April 2017, two students will be selected, one for a one year term and the other for a two year term. This policy will be reviewed in March 2018.
