REVIEW OF THE MINUTES OF November 21, 2017

NEW BUSINESS

POLICY A-01: STUDENT TRUSTEES ON BOARDS

Superintendent of Education Paula MacKinnon shared that this policy was revised last year as a one-year pilot to allow student trustees to serve up to two successive one-year terms. Student trustees received positive feedback that included the appreciation of having a mentor and felt this would better prepare them to work on long term initiatives. In addition, this would help student trustees to earn a position at the provincial level. Superintendent Paula MacKinnon changed the sentence structure in the first paragraph for clarity.

POLICY G-11: ASSAULT/THREATENING INCIDENTS INVOLVING STUDENTS

Superintendent of Education Kelly Pisek presented this policy on behalf of Board Lawyer Jennifer Feren and shared that we received no feedback. References were added and updated that are relevant to this policy. Superintendent Pisek suggested that PPM 145 be referenced in this policy as well and the committee agreed.

POLICY G-15: STUDENT MEDICAL FORMS

Superintendent of Education John Dickson presented that PPM 161 supports this policy. Updates to this policy include terminology, grammar and language for clarity. Superintendent Dickson suggested that number five under School Board Responsibilities be removed, as it is procedural and is referenced in the corresponding internal administrative procedure. In addition, number seven be a continuation of number six.

POLICY G-26: USE OF MOBILE DEVICES BY STUDENTS

Superintendent of Education Wes Hahn and IT for Learning Administrator Rosemary Jellinck stated that they received feedback from PIC, IT for Learning and the Information Technology Liaison Committee. Updates included tidying up language to align with the current framework. In addition, references were updated and changes were made to reflect current practise. Superintendent Hahn made a recommendation to change the review date to align with policy D-01: Digital Technology Use by Students as they interconnect.

POLICY A-19: ACCESSIBILITY STANDARDS - POLICY STATEMENT

Superintendent of Human Resources Lora Courtois and Health and Safety Officer Michael Langlois stated that no feedback was received. Updates were made to terminology and under legal framework, Accessibility Standard for Customer Service, Ontario Regulation 429/07 was removed as it has been repealed and replaced with Ontario Regulation 191/11, Integrated Accessibility Standards. The DSBN Accessibility Plan has been updated with current dates and references have been updated that tie into this policy. The committee agreed to remove Policy Statement from the title.

POLICY J-02: ACCESSIBILITY STANDARDS FOR SCHOOL TRANSPORTATION

Superintendent of Education Michael St. John shared that no feedback was received. Minor changes were made to reflect current terminology and references have been updated. School Support Services has been updated to Special Education Support Services to reflect current practise. Under legal framework, the committee agreed to remove Ontario Regulation 429/07, Accessibility Standards for Customer Service as it has been repealed. The committee recommended that all upcoming policies for review related to accessibility standards be included on the Special Education Advisory Committee (SEAC) meeting agenda for feedback purposes.
