POLICY E-02: SEXUAL HARASSMENT

Board Lawyer Jennifer Feren presented new policy G-39: Human Rights Discrimination and Harassment or Occupational Health and Safety Workplace Harassment. This new policy was developed to combine policy E-02: Sexual Harassment and E-09: Human Rights. It defines grounds of discrimination and addresses dealing with the Ontario Human Rights Code to provide a safe environment. Board Lawyer Jennifer Feren added that this policy aligns with the newly developed administrative procedure as well. No feedback was received.
