BUSINESS ARISING FROM THE MINUTES

Chair Schaubel asked if there was business arising from the minutes, and there was none.

NEW BUSINESS

Boundary Changes - Elementary Schools - Quaker Road and Glynn A Green

Superintendent Stacy Veld presented proposed boundary changes in Pelham and Welland that the Planning department, along with Niagara Student Transportation Services (NSTS) recommended. It was determined that shifting a portion of the boundary eastward along Holland Road to Cataract Road would improve transportation as well as provide clarity to boundary lines. NSTS requested that the Cataract Road area south of Holland Road to Regional Road 20 also be included which would place the entire area into one school boundary and would be served by one bus. The proposed changes affect only one Junior Kindergarten student who will be grandfathered and will have the option to attend either school with transportation for the remaining 2017-2018 school year and will attend Glynn A. Green for the 2018-2019 school year and thereafter.

"That, effective November 29, 2017, the following District School Board of Niagara elementary and secondary school boundary transfers be approved:

Zone A, as shown on Appendix A:

- From Richmond Street PS to Glynn A. Green PS for the regular track program,
- From Jeanne Sauvé PS to Gordon PS for the French Immersion program,
- From Connaught PS to Fitch Street PS for the English as a Second Language program;
- From Thorold SS to E.L. Crossley SS for the regular track program,
- From Sir Winston Churchill SS to Welland Centennial SS for the Extended French program,
- From St. Catharines Collegiate to Welland Centennial SS for the English as a Second Language program, and
- From St. Catharines Collegiate to Eastdale SS for the Specialized School to Work program;

Zone B, as shown on Appendix A:

From Quaker Road PS to Glynn A. Green PS;

and,

That the current junior kindergarten student at Quaker Road PS be grandfathered and have the option to attend either school with transportation."

Boundary Changes - Secondary Schools - Eastdale and Welland Centennial

The chair invited Superintendent Paula Mackinnon to speak to proposed boundary alignments in Welland. The current boundary between Eastdale SS and Welland Centennial SS does not align with the elementary boundaries of Fitch Street PS and Ross PS. The implementation of this boundary change would occur in semester two of the current school year. The Superintendent clarified for the Committee that the number of students affected would not have an impact on Eastdale's enrolment.

"That, effective February 5, 2018, the following District School Board of Niagara secondary school boundary transfers be approved:

Zones B and D, as shown on Appendix A and B, be transferred from Eastdale SS to Welland Centennial SS;

and,

That current Eastdale SS students in this boundary be grandfathered and have the option to attend either school with transportation."

School Consolidation - Wainfleet Elementary Schools

Superintendent John Dickson presented a proposal for a multi-use school involving three elementary schools in Wainfleet. Two DSBN schools, Winger PS and W.E. Brown PS, and St. Elizabeth Catholic Elementary School. He explained that a new school would provide specialized programming and strengthen professional learning opportunities amongst teachers in a multi-use space, as well as providing steady enrolment numbers.

"That the Board request the Niagara Catholic District School Board to support a jointuse school project for the three elementary schools (Winger, William E. Brown and St. Elizabeth) in the Township of Wainfleet.

and

If Niagara Catholic District School Board supports a joint-use school project for the three elementary schools (Winger, William E. Brown and St. Elizabeth) in the Township of Wainfleet, then and only then Senior Administration are directed to prepare an Initial Staff Report and School Information Profile Reports for William E. Brown PS and Winger PS for presentation to the Board of Trustees; otherwise, the Wainfleet elementary accommodation review process will not move forward."
