English/French Education Verification Letter

An English/French Education Verification Letter is generally used to prove that a student attended English/French-speaking schools while living in Ontario. The letter lists the schools attended by the student in Ontario with the dates of attendance at each school. The letter also states that the language used to teach the classes at each school was English.

ENGLISH LETTER: Used to prove that a parent was taught in English to enrol children in English-speaking schools in Québec. FRENCH LETTER: Used to prove that a parent was taught in French to enrol children in French-speaking schools in Ontario.

Either letter can also be used to prove that a person attended school in Ontario.

Student records are confidential and English/French Education Verification Letters are issued only at the written request of the student and are subject to the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA)

Requests for English Education Verification Letters are completed in the order in which they are received. Processing time depends on how long you have been out of school and the number of people already in line in front of you.

Processing time is generally 5 to 7 business days

During peak periods, processing time may be longer

than normal
