- Also Trustees approved the motion: "That the Board write a letter to the Ontario Ministry of Education expressing the Board's concerns related to EQAO assessments and to request the Ontario Ministry of Education pause EQAO testing for the 2017-2018 school year." The Board believes EQAO should be looking into accommodations, cultural relevance, and student well-being as they review the testing model.
- DSBN Trustees elected Dale Robinson as Chair and Kevin Maves as Vice-Chair.
