## **TRUSTEE UPDATE**

Trustee Lora Campbell shared the following:

- The DSBN Board of Trustees wrote to EQAO to request that student results for the recent online administration of the Ontario Secondary School Literacy Test (OSSLT) be counted on students' records. The DSBN had 3,191 students take the OSSLT online pilot test. Of those, 2,020 students completed the entire test. The Board recognizes that both students and staff worked hard to prepare for the online OSSLT and the frustration of parents/guardians. EQAO responded to the Board's letter and we are delighted that they will be scoring the tests and for those who were unable to complete it, other opportunities will be provided in the spring.
- The first Public Meeting of the West Niagara Accommodation Review was held on November 10th. The second Meeting will be held on December 15th at Beamsville District Secondary School followed by a third meeting on January 26<sup>th</sup> at Grimsby Secondary School.
